On August 23, 2023, the Public Utilities Commission (Commission) issued a procedural order approving the assented-to proposed procedural schedule filed by the New Hampshire Department of Energy (Department) on August 22, 2023 in the above captioned docket. As noted by the Commission, the approved procedural schedule includes a technical session on November 9, 2023, but does not include the time at which the technical session will occur. In the August 23<sup>rd</sup> Procedural Order, the Commission requested that the Department file a notice with the assent of the parties indicating the time at which the technical session will occur, in order to allow the Commission to accurately calendar the technical session and avoid potential scheduling conflicts.
