**Procedural Order Re: Commission Approval for TYR Energy, LLC White Paper Filing
by June 20, 2024 (Ref.: Hearing Exhibit 17)**

On March 29, 2024, the Commission issued Order No. 26,984 in this instant docket, approving the Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty (Liberty or the Company) petition for modifications to its Default Service procurement process, made in response to a Commission directive.

At the March 20, 2024 hearing for this matter, Liberty committed to provide, as future Hearing Exhibit 17 and as a response to a Commission record request, an analytical paper (White Paper) to be jointly developed by the Company and by Tyr Energy, LLC (Tyr Energy) assessing the costs and impacts of various call-option strategies on energy pricing outcomes, using historical LMP data for the ISO-New England market. Order No. 26,984 at 4.

Liberty filed a proposal for the parameters of the White Paper on April 10, 2024, providing technical details for the scope of the White Paper, noting the expected cost of \$17,000, and requesting the Commission's approval. Liberty noted that the White Paper would be prepared by Tyr Energy within eight weeks after Commission approval. No responses to the Company's April 10 filing have been made by any party.


Having reviewed the parameters for the White Paper presented by the Company in its April 10 filing, the Commission finds that they are satisfactory, and incorporates them by reference here. The Commission further orders that the White Paper be filed with the

Commission no later than June 20, 2024, and that Hearing Exhibit 17 in this proceeding remain reserved for this material.


