ORDER NO. 3

1           In the Final Report and Order the NDFC determined that all of the monies,  
2           except for one dollar in each Escrow Account, held in the Funding Assurance  
3           Escrow (“Escrow”) for Taunton Municipal Lighting Plant (“Taunton”) and  
4           Hudson Light and Power Department (“Hudson”) are to be transferred to their  
5           respective Decommissioning Trust accounts. Through the Seabrook Station  
6           Managing Agent, FPLE Energy Seabrook, LLC, Taunton and Hudson agree that  
7           the transfer is appropriate.

8           Pursuant to the Second Amended and Restated Escrow Agreement dated  
9           as of December 22, 2006, among FPL Energy Seabrook, LLC, Massachusetts  
10          Municipal Wholesale Electric Company, Taunton Municipal Lighting Plant  
11          (“Taunton”) and Hudson Light and Power Department (“Hudson”), the NDFC  
12          and the State Treasurer, monies deposited in the Escrow may only be withdrawn  
13          at the direction and when authorized by the Nuclear Decommissioning Financing  
14          Committee (“NDFC”). Escrow Section 2(a), at 5. The Escrow established the  
15          New Hampshire State Treasurer as the Escrow Agent. Escrow at 1.

16          Accordingly, the NDFC directs that the monies held in the Escrow for  
17          Taunton and Hudson be transferred to their respective Decommissioning Trust  
18          accounts, with one dollar to remain in Escrow account of each company.

20 Accompanying this Order are Release Certificates directing that those transfers be  
21 made.
