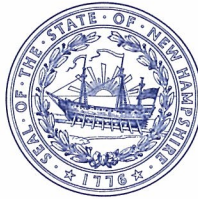

Complaint Against Verizon New Hampshire re: Access Charges
Rescheduling of Prehearing Conference

On August 14, 2008, Sprint Nextel (Sprint) filed a request to reschedule the pre-hearing conference currently scheduled for October 1, 2008 in Docket No. DT 06-067 because it falls during the Jewish New Year holidays.

On September 8, 2008, Verizon filed a motion to stay proceedings in Docket No. DT 06-067 pending its appeal of Commission Order No. 24,886 to the New Hampshire Supreme Court pursuant to RSA 541:6. On September 18, 2008, AT&T, BayRing Communications, One Communications and Sprint filed a joint opposition to Verizon's motion to stay,

The Commission has determined to reschedule the prehearing conference pending review of Verizon's motion to stay and the joint opposition to that motion. Accordingly, the Commission has rescheduled the prehearing conference to Wednesday, November 5, 2008.
