- Each aggregator shall re-file with the Commission an up-to-date written notice of intent to provide service as an aggregator every 2 years on or before its original notice anniversary date, which is the date on which the Commission received the applicant's <u>initial</u> notice of intent.
- There is NO re-registration fee provided that the re-filing is made in a timely manner.


