#### Petition For Intervention of The Way Home

Petitioner, The Way Home, petitions for leave to intervene in this proceeding, pursuant to Puc 203.17 and RSA 541-A:32, and states as follows:

The Way Home is located at 214 Spruce Street, Manchester, New Hampshire
03103 (ph.) 603-627-3491. The Executive Director of The Way Home is Mary Sliney.
The Director of Housing Services is Dianne Pitts.

2. The Way Home is a non-profit 501(c)(3) organization. The Way Home was incorporated in New Hampshire in 1989 and is registered with and in good standing with the Office of the Secretary of State. The Way Home is funded in part by the Heritage United Way and by other grants.

3. The Way Home is a commercial customer of Public Service Company of New Hampshire (PSNH).

4. The mission of The Way Home is to help low income households obtain and keep safe, affordable housing and prevent homelessness in New Hampshire. The Way Home provides housing services to low income individuals and families in the Manchester area, including education, housing and budget counseling, security deposit guarantees, special grants to prevent homelessness, community advocacy, mediation services, and lead paint hazard reduction. Attached to this Petition is a brochure describing some of the programs and services of The Way Home. 5. During the past 19 years over 5,000 families and individuals have been housed with the help of programs of The Way Home.

6. The Way Home also provides seven units of transitional housing for low income families. These seven units use electricity provided by PSNH.

7. Due to their low incomes, clients of The Way Home who are electric customers are or may be eligible for and/or participate in the current Electric Assistance Program (EAP), and may be eligible for the 2008-09 Electric Assistance Program.

8. The Way Home, clients of The Way Home who are electric customers, and the families who reside in the transitional housing units of The Way Home have an interest in this proceeding and in the funding, costs, design and administration of the EAP.

9. The rights, duties, privileges and other substantial interest of The Way Home and its clients may be affected by this proceeding.

10. The Way Home seeks the status of a full party intervenor in this proceeding on behalf of its clients who are electric customers and the families who reside in its transitional housing units.

11. The Way Home participates on the Commission's Electric Assistance Program Advisory Board.

12. The Way Home has participated as a full party intervenor in prior proceedings before this Commission pertaining to the EAP, including dockets DE 06-079 and DE 07-009.

13. The Way Home has also participated as party intervenor in electric and gas energy efficiency dockets before this Commission.

14. The granting of this petition will not impair the prompt and orderly conduct of this proceeding, will not result in delay, and will not prejudice the interest of any party.

15. The interests of justice will be promoted by allowing the intervention of The Way Home in this proceeding.

Wherefore, The Way Home requests that the Commission grant its request for leave to intervene as a full party intervenor in this proceeding and for such other relief as may be just.

- Housing Assistance includes
  - \* security deposit guaranteer

  - \* mediation to prevent eviction.

Security Deposit Guarantee: In 1993 The Way Home's Socially Deposit Guarantee became the model for the State of New Hampshire Housing Security Guarantee Program. While the landlord is guaranteed the socially deposit, the transit is helped to make budgeted monthly payments. By working with a housing counselor, the transit is guided in solving publicuts that could usual in homelessness.

Rental Guarantee: In 2000-02 a program in provide incentives in property-owners to house homeless families with children was developed.

## in Affordable Housing

• Steps to Success

- Finding The Winner Within O, gives participants empowerment tools designed to remove blocks to success, raise their selfesteem, and help them make decisions about what they allow to shape their lives.
- Family Self-Sufficiency Coaching teaches family goal-setting skills and coaches in steps to achieve goals.
- Housing Advocacy helps homeless and at-risk families to advocate on their own behalf with landlords and agencies to meet their safe, affondable housing needs.
- Temporary Hossing helps families meet their immediate housing needs while assisting them to develop skills for success in safe, affordable housing. The facility combines six private apartments with common areas for family and community activities, tutoring, and comprehensive supportive services. Eligibility:
  - families with young children at risk of lead poisoning or other health problems due to hazards in the home
  - homeless families using our Steps to Success training with peer support.

The Way Home's 214 Spruce St. facility opened Spring 2002 as a Housing Resource Center with Temporary Housing for Families.

# O- Healthy Home Services

- Housing Safety and Child Health are linked in our unique services combine peer educators working with families in their homes with specialized cleaning and supportive services to reduce in-home environmental health hazards such as lead dust, asthma triggers, and head lice.
- Lead Paint Hazard Reduction, as a feefor-service for property owners, includes consultation with our Licensed Lead Abatement Contractor on interim controls and lead-safe work practices. Healthy Home Services staff can assist with lead hazard reduction activities:
  - lead dust cleaning
  - · paint stabilization
  - covering hazards, such as friction surfaces and chewable surfaces
  - · replacement windows and clean-up.

# - Community Advocacy

Community Advocacy works on low income housing issues with groups such as The NH Coalition to End Homelessness, the NH Housing Forum, and Manchester's Homeless Continuum of Care.
