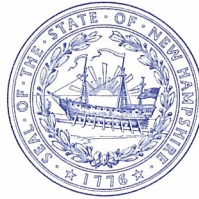

On February 5, 2009, a duly noticed Prehearing Conference was held in the above referenced proceeding. Appearances at the Prehearing Conference were entered by representatives of Public Service Company of New Hampshire, Home Builders & Remodelers Association of New Hampshire, the Office of the Consumer Advocate (participating as a full statutory party), and Commission Staff.
