

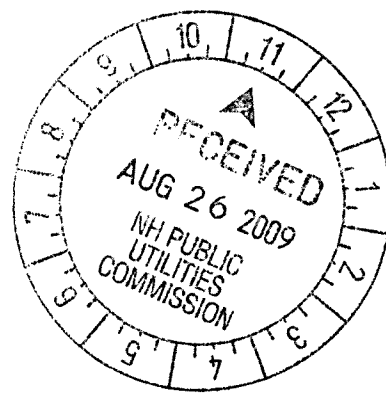

Dear NH PUC:

Please accept this letter and attached documentation, required by the New Hampshire Administrative Code Public Utility Commission Rules Pursuant Section 2504.01(a)(2)(a-e) – Location of Sources Issuing Certificates, as verifiable evidence in order to continue certification eligibility for the Mill Seat landfill gas-to-energy facility located at 310 Brew Road, Bergen, New York, 14416, 6.4 mega-watts:


- a) Documentation of a unit-specific bilateral contract or other legally enforceable obligation that is executed between the source owner, operator, or authorized agent and an electric energy purchaser located within the New England control area for delivery of the source's electric energy to the New England control area; **there have been no changes in the executed power purchase agreement between source owner and electrical energy purchaser as of August 19, 2009, quarter two report submittal.**
- b) Proof of associated transmission rights for delivery of the source's electric energy from the generation unit of the source through the adjacent control area to the New England control area; **See (d) for transmission rights delivery for the source's electric energy transmission rights – NERC tags.**
- c) Documentation that the electrical energy delivered was settled in the ISO-New England wholesale market system; **the energy purchaser is currently managing the electrical energy output, which settled electrical energy may be verified via the NEPOOL-GIS tracking system.**

- d) Documentation that the source produced, during each hour of the applicable month, the amount of megawatt-hours claimed, as verified by the GIS administrator; **Commission staff have been provided a Template Quarterly Report to NEPOOL-GIS for Imports submitted by energy purchaser to source owner to serve as documentation that the source produced, during each hour of the applicable month, the amount of megawatt-hours claimed, as verified by the NEPOOL-GIS Administrator and attached attestations.**
- e) Confirmation that the electrical energy delivered under the legal obligation received a North American Electric Reliability Corporation ("NERC") tag from the originating control area to the New England control area. See listed NERC tags. **Below, please find a list of NERC tag confirmations for Mil Seat, which may be verified via the Template Quarterly Report to NEPOOL-GIS as confirmation that the electrical energy delivered under the legal obligation received a NERC tag.**

Imported Unit Energy Seller Certification

WM Renewable Energy, LLC (Mill Seat), with its principal office in Houston, Texas ("Seller") certifies to the Participants in the New England Power Pool that, other than the Sale (defined below), it has not retired, sold, claimed, represented as part of Energy sold elsewhere, or used to satisfy obligations in any jurisdiction outside of New England any of the fuel source, emission or labor attributes (the "Attributes") associated with the Imported Unit Energy it sold to Constellation Energy Commodities Group during Q2 2009, with its principal office in Baltimore, MD (the "Sale"). Seller further promises that it will not retire, sell or claim the Attributes, represent the Attributes as part of Energy sold or use the Attributes to satisfy Obligations in another jurisdiction, other than in connection with the Sale.
