Certification Application for Class II Eligibility pursuant to RSA 362-F

Dear Ms. Ranade:

On November 25, 2008, Essex Meadows Properties, Inc. (Essex Meadows) submitted an application requesting certification of its Essex Meadows solar photovoltaic facility (Essex Meadows facility) as eligible to produce Class II renewable energy certificates (RECs) pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law. Staff has reviewed the application and recommended approval noting that the Essex Meadows application was complete on January 30, 2009.

Class II eligibility requires that a facility began operation after January 1, 2006 and that it produces electricity from solar technologies. The application indicates that Essex Meadows has installed solar photovoltaic equipment with a gross nameplate capacity of 0.095 megawatts located at 30 Bokum Road, Essex, Connecticut and that the facility began commercial operation on October 3, 2008. The NEPOOL GIS facility code has not yet been obtained. Essex Meadows will provide the facility code to the Commission as soon as it is obtained from the GIS administrator. The ISO-NE asset identification number is not applicable as the Essex Meadows facility is a behind-the-meter source.

The Commission has reviewed the Essex Meadows application and determined that it has provided all the necessary information to demonstrate that the Essex Meadows facility is eligible for certification as a Class II facility. Therefore, the Commission hereby certifies that the Essex Meadows facility is a Class II renewable energy source effective January 30, 2009 and is eligible to be issued New Hampshire Class II renewable energy certificates.

Attached please find a copy of the notice of this certification provided to the GIS administrator. The New Hampshire Renewable Portfolio Standard certification code for the Essex Meadows solar photovoltaic facility is NH-II-09-013.



Please be advised that, pursuant to NH RSA 362-F, the New Hampshire Public Utilities Commission has certified the Essex Meadows solar photovoltaic facility as a Class II renewable energy source effective January 30, 2009. Accordingly, the Essex Meadows facility is eligible to be issued New Hampshire RPS Class II renewable energy certificates.

The Essex Meadows Property, Inc. has installed solar photovoltaic equipment with a gross nameplate capacity of 0.095 megawatts located at 30 Bokum Road, Essex, Connecticut. The facility began commercial operation on October 3, 2008. The NEPOOL GIS facility code has not yet been obtained.
