The purpose of this filing package is to 1) provide supporting documentation for the Special Contract for Centrex Service between FairPoint Communications-NNE and Dartmouth Hitchcock Clinic and 2) request full approval of this Agreement from the New Hampshire Public Utilities Commission.

- 1. TERM. The Term of this Agreement is hereby extended to and shall expire on June 28, 2009.
- 2. SERVICE MIGRATION. The parties hereto agree that Customer is in the process of migrating services as provided under and described in the Agreement to alternative services provided by FairPoint Communications-NNE and the parties further agree that so long as Customer migrates services as provided under and described in this Agreement to such alternative services provided by FairPoint Communications-NNE then FairPoint Communications-NNE shall waive any early termination liability ordinarily associated with such termination of services provided under and described in the Agreement. Such waiver of early termination liability is conditioned upon and shall only be applicable if Customer purchases and migrates to the alternative services as provided by FairPoint Communications-NNE.
