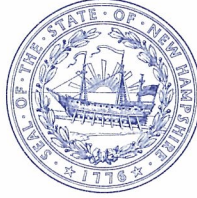

On January 26, 2009, the Commission designated General Counsel Anne Ross to arbitrate the above-captioned matter and to report her findings by February 11, 2009. On February 11, 2009, Staff filed a request to extend the deadline to file the report until February 27, 2009 in light of the "number of routes in question and the unavailability of inter-office fiber inventory records."

The Commission has determined that extending the deadline in which to file the report will not unduly delay the proceeding or adversely affect the rights of any party. Accordingly, the deadline for filing the report in this matter is extended to close of business on February 27, 2009.
