Dear Mr. McNeil:

On December 7, 2009, you submitted applications on behalf of homeowners Barton N. Green, Gilbert W. Sutcliffe, Harriet B. Forkey, John E. Nyblom and Arnold R. Miller requesting certification of customer-sited rooftop photovoltaic facilities as eligible to produce Class II renewable energy certificates (RECs) pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law. Staff has reviewed the applications and recommended approval noting that the applications were complete on December 7, 2009.

Class II eligibility requires that a facility began operation after January 1, 2006 and that it produces electricity from solar technologies. The applications indicate that the facilities are customer-sited photovoltaic rooftop arrays located in New Hampshire and that they began operation in 2009. The details for each facility are listed in the table on the following page.

Since the facilities are customer-sited sources, their output is not recorded in the NEPOOL Market Settlement System and, as a result, their output must be monitored and verified by an independent monitor. The applications state that NHEC will monitor the facilities' output as required by N.H. Code of Admin. Rules Puc 2505.08.

Based on Staff's recommendation, the Commission has determined that NHEC has provided all the necessary information to demonstrate that the facilities are eligible for certification as Class II facilities. Therefore, the Commission hereby certifies that the Barton N. Green, Gilbert W. Sutcliffe, Harriet B. Forkey, John E. Nyblom and Arnold R. Miller facilities are Class II renewable energy sources effective December 7, 2009 and are eligible to be issued New Hampshire Class II renewable energy certificates.

The New Hampshire Renewable Portfolio Standard certification codes for the NHEC solar photovoltaic facilities are listed in the previous table.

¹ NHEC considers the operation date listed in the table above, and in Appendix E of each application, to be the date on which NHEC inspected the facility and installed a revenue quality meter to record the electricity that will be eligible for Class II RECs. The date listed in each interconnection application pertains to the installation and interconnection of the facility and may be different than the operation date listed in the above table.
