DE 10-024: Request to establish SED FY14 program budgets

This is to request approval to establish program budgets for the Renewable Energy Fund for FY14 as set forth in Table 2 below. In addition to setting new funding levels for existing rebate and grant programs, this proposed budget includes funds for a new commercial and industrial wood chip/pellet boiler rebate program. ¹

Under the current state budget, the Commission is authorized to spend \$7,838,062 of new revenues in state fiscal year 2014 (July 1, 2013 through June 30, 2014). With the Commission's approval these funds will be allocated as follows:
