Customer Migration Motion for Clarification

To the Parties:

On August 25, 2011, Constellation Energy Commodities Group, Inc. and Constellation NewEnergy, Inc. (Constellation) filed a so-called request for clarification of certain portions of Order No. 25,256 (July 26, 2011). Constellation acknowledged that the Commission concluded at page 34 of the Order that requiring PSNH to offer an RFP for Full Requirements Service for its default service load was not in the public interest at this time, but it nevertheless asked that the Commission address potential future changes which might result in PSNH's default service load exceeding its owned generation output.

Although Constellation filed its request pursuant to RSA 541:3, which pertains to motions for rehearing, and describes its request as one for clarification, the request is more properly described as a request for supplemental findings. The Commission has considered Constellation's request and concluded that it would be inappropriate to supplement Order No. 25,256 in the manner requested. Accordingly, Constellation's August 25, 2011 request has been denied.
