PETITION TO INTERVENE

NOW COMES US Energy Saver LLC (USES), a for-profit business, and respectfully requests leave to intervene as a party in the above-referenced proceeding pursuant to Rule PUC 203.2 and RSA 541-A:32, I(b). In support of this petition, USES states the following:


1. USES is a small, entrepreneurial business organized in New Hampshire that serves the needs of consumers, organizations and policy-makers in the energy services market, particularly in helping its customers in their efforts to discover and implement cost-effective energy efficiency and renewable energy solutions. USES has extensively studied and continues to monitor the growth and innovation in the energy services marketplace, both in New Hampshire and in other regions of the United States.
2. USES has an interest in seeing the New Hampshire market for energy efficiency and renewable generation services grow, for that market to be accessible to all who want to participate in it, and in seeing that programs administered on behalf of the State of New Hampshire have the greatest stimulative and transformative effect on the energy efficiency marketplace, balanced with a goal of achieving the greatest leverage of private dollars for each publicly-funded dollar invested in such programs and projects.
3. USES has volunteered to participate in the discussions of the Energy Efficiency and Sustainable Energy (EESE) Board and several of its working groups to help craft a cohesive strategy for energy efficiency and sustainable energy for New Hampshire. USES has also testified before several committees of the New Hampshire House and Senate to advocate for new and more effective policies and programs in support of energy efficiency and renewable energy within New Hampshire. USES was also participated in NH PUC Docket DE-09-170 regarding the 2010 CORE New Hampshire Energy Efficiency Programs. Russell Aney is also a member of the Town of New London's Energy Committee, and, in that role, has served as the town's coordinating person regarding a number of energy efficiency projects, including projects that participated in the PSNH Core programs.

4. Mr. Aney would like to advise the Commission that he is advising Mr. Daniel Ramage, Mr. R. Jeremy Hill and the New Hampshire Energy Trust, a New Hampshire non-profit corporation that is in the process of formation, through a consulting arrangement. They are intending to intervene separately in this docket, and they do not perceive any conflict of interest in the arrangement.
5. The expertise and interest of USES in the matters that are the subject of this docket would benefit the Commission's investigation. The intervention of USES would be in the interest of justice and would not impair the orderly and prompt conduct of the proceedings.

WHEREFORE, US Energy Saver LLC requests that the Commission grant this motion, allow US Energy Saver LLC to intervene as a full party intervener in this proceeding, and grant such other relief as is just and proper.


