**Re: DE 10-212, Commercial and Industrial Solar Rebate Program
Establishment of Wait List for Category 1 Incentive Applications**

To all Interested Parties:

As of 2:00 pm on May 5, 2016, the budgeted funding for the Category 1 commercial and industrial (C&I) solar rebate program (Program) was fully reserved. Per the Program terms and conditions, applications will be placed on a waitlist until additional funding becomes available. The budget approved for the Category 1 C&I Program for fiscal year 2016 is \$3,977,801.

Pursuant to the Orders for this Program, Staff developed applications for the C&I solar incentive. Condition 11 in the Step 1 application developed per Order No. 25,764, and Condition 9 of Appendix A, General Program Terms and Conditions in the Step 1 application developed per Order No. 25,878, both state as follows:

Once all allocated funds are reserved, applications will be placed on a waitlist based on their queue position. Applications on the waitlist will not be processed or reviewed until funding is available. There is no guarantee that any funding will be available for waitlisted applications.

As noted, as funding becomes available, applications will be removed from the waitlist in the order in which they were received and processed and reviewed. Staff anticipates that additional funding will become available after July 1, 2016, or possibly earlier, if approved projects do not move forward or the requested rebate is reduced or denied.
