On October 07, 2011, Tioga Solar Westborough, LLC (TSW) submitted applications on behalf of BJ's Wholesale Club, Inc. requesting certification of two customer-sited rooftop photovoltaic facilities (BJ's facilities) as eligible to produce Class II Renewable Energy Certificates (RECs) pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law. Staff has reviewed your applications and recommended approval noting that the applications were completed on December 23, 2010.

Class II eligibility requires that a facility began operation after January 1, 2006 and that it produces electricity from solar technologies. The applications indicate that the facilities are customer-sited photovoltaic rooftop arrays located in Massachusetts and the facilities began operation on July 8, 2010. The details for each facility are listed in the following table.

Your applications indicate that the BJ's facilities are behind-the-meter sources and that National Semiconductor, as the facilities' independent monitor, will verify and report the facilities' output to the NEPOOL Generation Information System (GIS) pursuant to the GIS Operating Rules. Each facility's NEPOOL GIS facility code is listed in the table on the previous page.

Based on Staff's recommendation, the Commission has determined that TSW has provided all the necessary information to demonstrate that the BJ's facilities are eligible for certification as Class II facilities. Therefore, the Commission hereby certifies the BJ's facilities as Class II renewable energy sources effective December 23, 2010 and are eligible to be issued New Hampshire Class II RECs.
