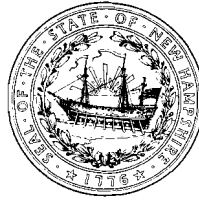

Dear Ms. Hamilton:

On May 6, 2011, the New Hampshire Public Utilities Commission (Commission) received an application from Conservation Services Group on behalf of Princeton Crossing L. P. (Princeton Crossing) requesting certification for the Princeton Commons photovoltaic facility as a Class II renewable energy source pursuant to RSA 362-F, New Hampshire's Renewable Portfolio Standard law. Staff has reviewed your application and has noted the following items that must be addressed before your application is considered complete:

- 1.) Section II of your application identifies one 22.4 kilowatt (kW) photovoltaic facility located at 1 Technology Drive, Chelmsford, Massachusetts. However, the attachments to your application include four interconnection applications for facilities located on four separate buildings at 1 Technology Drive, each having a nameplate capacity (direct current) ranging from 16.1 kW to 26.68 kW. Does Princeton Crossing wish to certify only one facility or all four facilities?
- 2.) If Princeton Crossing wants to certify all four facilities, does it also want to include these facilities in its aggregation approved by the Commission in DE 10-156?<sup>1</sup>



<sup>1</sup> In DE 10-156, the Princeton Crossing aggregation was assigned the New Hampshire facility code of NH-11-10-091.

- 3.) If Princeton Crossing wishes to certify all four facilities under a new aggregation, what is the NEPOOL GIS facility code?
- 4.) Exhibit F of the Interconnection Service Agreement references only buildings 1 and 3. Would you please provide the interconnection agreement(s) for buildings 2 and 4.
- 5.) Attachment 2 of the interconnection agreement states that Massachusetts Electric Company (MEC) will install a new bidirectional power flow meter at each building. Has MEC installed all of these meters? If so, please provide each facility's meter installation date.
- 6.) Have these facilities and the resulting aggregation been certified to receive renewable energy certificates under another state's renewable portfolio standard program? If so, please provide supporting documentation.

These items must be received by the Commission to complete your application. Until such time, it will not be processed. If the requested information and documentation are not provided within ten business days, your file will be closed without prejudice.
