On October 06, 2011 you submitted an application on behalf of Scott Moriearty requesting the Commission grant approval of the photovoltaic facility located at the Moriearty residence to produce Class II, Renewable Energy Certificates (RECs) pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law. Staff has reviewed this application and has recommended approval of the Moriearty residence facility as eligible for Class II RECs effective October 06, 2011.

Since this facility is a customer-sited source, the output is not recorded in the New England Power Pool Market Settlement System and, as a result, the output must be monitored and verified by an independent monitor. Your application states that NHEC will monitor the facility's output as required by N.H. Code of Administrative Rules Puc 2505.08 and 2505.09. This facility's total output will also be included in the NHEC Class II Aggregation's total output reported to the NEPOOL Generation Information System as approved by the Commission on April 9, 2010.
