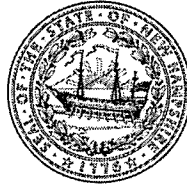

The Commission held a prehearing conference in the above-captioned docket on April 26, 2012, before Hearings Examiner Suzanne Amidon, Esq. I participated in the prehearing conference as Staff counsel on behalf of Marcia A.B. Thunberg, Esq., the Staff Attorney assigned to this case. Following the prehearing conference, representatives of Staff, the Office of Consumer Advocate (OCA) and the Company met in a technical session to discuss a recommended procedural schedule.
