RE: DM 12-005 -- Hess Corporation Competitive Electric Power Supplier License Renewal – Response To First Deficiency Notice

Dear Secretary Howland:

Hess Corporation ("Hess") submits this letter in response to Commission Staff's First Deficiency Notice (sent to my attention via e-mail from Staff member Al-Azad Iqbal on February 6 2012) as follows:

- 1. On January 6, 2012 Hess submitted its CEPS license renewal in the above referenced matter. In making this submission, Hess relied on the statement contained in the Commission's March 10, 2010 re-licensing letter in Docket DM 10-005 that Hess would be "required to re-register [for a renewed CEPS license] on or before February 14, 2012." Subsequently, we discovered that rule Puc 2003.02(a) had been revised to require that each CEPS renewal application be filed at least 60 days prior to the end date of its current registration. Hess apologizes for this internal confusion regarding its re-licensing submission and respectfully requests pursuant to rule Puc 201.05 a waiver from rule Puc 2003.02(a) for purposes of the submission of its January 6, 2012 application for renewal of its CEPS license. Hess respectfully submits that such a waiver for this purpose will not disrupt the public interest nor will it disrupt the orderly and efficient resolution of matters before the Commission.
- Pursuant to rule 2003 03(a)(5), each CEPS must post financial security for purposes of renewal with an expiration date not less than 5 years and 90 days after the date the applicant's application is filed." Hess' current CEPS bond (Bond No 929375027) runs through December 1, 2012. Enclosed please find an executed continuation certificate to keep Bond No 929375027 in effect as valid and binding through May 31, 2017 in order to bring it into full compliance with rule Puc 2003.03(a)(5).
