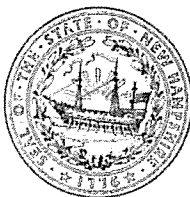

Re: DT 12-016: Petition to Amend CLEC and CTP Authority

Dear Ms. Laine and Mr. Paladini:

On January 12, 2012, Time-Warner Cable Information Service (New Hampshire), LLC (Time-Warner) petitioned the Commission to amend its existing authority to offer competitive local exchange service granted in Order No. 24,356, dated July 27, 2004, and its authority to offer interexchange telecommunications service, granted by secretarial letter of June 19, 2008. In both cases Time-Warner seeks to expand its authorization from those areas formerly served by Verizon Communications, to include all other areas today served by Northland Telephone of Maine, Inc. d/b/a FairPoint Communications, and/or Northern New England Telephone Operations LLC d/b/a FairPoint Communications (collectively, FairPoint).

The two requests to expand areas of authorization have each been approved, and have been documented in the attached certificates: CLEC certification CL-01-002-12 and Interexchange Carrier certification IXC-01-003-12.

As a reminder, as Time-Warner business in New Hampshire, the Commission expects the company to comply with all applicable rules and provide the highest level of customer service. The filing requirements that Time-Warner has previously followed remain in effect, including requirements for annual reports due March 31st of each year.

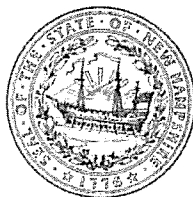
