Motion for Clarification

To the Parties:

On April 24, 2013, segTEL, Inc. (segTEL) filed in the above referenced proceeding a motion for clarification of the nature and scope of proceeding and specification of pending issues. segTEL requested clarification from the Commission in order to pursue litigation it had filed against New Hampshire Optical Systems (NHOS) in the Merrimack Superior Court. segTEL, Inc. v. University system of New Hampshire, et al, Docket No. 217-2013-CV-00023. (Superior Court Litigation)

The Commission has determined that, inasmuch as Order No. 25,407 (September 5, 2012) defined the scope of this docket, clarification is not necessary. To the extent that segTEL wishes to resolve issues not currently included within the scope of this docket, it is free to request an expansion of the scope, or to make a separate complaint with the Commission concerning NHOS' alleged actions regarding utility pole attachments.
