This letter is a proposal regarding the failing leach field at Common Area E, Phase V, Pulpit Rd, Bedford, NH. The repairs will be per the RFP.

Bedford RFP Rejuvenation

Leach Bed #1'& #2.

- Locate splitter box and distribution boxes. The splitter box outlet to the bed will be plugged to prohibit flow. The location of these structures will be recorded and marked to allow for ease of future access.
- Install equalizers, if there are none currently installed.
- Uncover the ends of each pipe in the bed and remove all end caps. Allow to sit open to the air, with no inflow of effluent for a minimum of 72 hours.
- Install differential vent pipes to ensure air flow throughout as stated in Enviroseptic
- Design & Installation manual.
- Backfill the system with proper material. Restore flow from the splitter box.

Timeline for Completion:

All work to be completed within 4 weeks, weather permitting.

Cost includes material and labor.....\$19,753.00
