Dear Mr. Eaton:

On August 19, 2004, the New Hampshire Public Utilities Commission (Commission) voted to approve an Initial Proposal for the Readoption, Repeal and Amendment of Puc 500, Rules for Gas Service and Gas Safety. The Rulemaking Notice was published in the Rulemaking Register on September 10, 2004. Pursuant to the Rulemaking Notice Form Appendix II-C, the Commission held a hearing on October 5, 2004. As stated in Appendix II-C, the Commission accepted written comments through October 18, 2004. The written comments are enclosed for your information.

Based upon the public comment, the Commission made certain changes to the Initial Proposal. The Commission subsequently adopted those changes on November 30, 2004.

The document enclosed entitled "Final Proposal" represents the annotation of those changes. In addition, you will find enclosed a document entitled "Final Proposal Fixed Text" which includes all changes to the document without annotation except for the inclusion of the repealed sections.

The changes required by public comment do not change any fiscal impact of the rules and therefore the Commission did not request a revised Fiscal Impact Statement.

Please note that the existing Puc 500, Rules for Gas Service and Gas Safety, expire on January 28, 2004. The Commission requests that the Final Proposal be placed on the Committee's agenda for December 16, 2004 and requests the Committee vote to approve the Final Proposal. The Commission makes this request because these Rules affect the public health and safety in that they require gas and liquefied petroleum gas suppliers to participate in the "Dig Safe" program, and regulate safety practices and accident reporting by gas utilities. The Commission must adopt the new Rules before January 28, 2004 in order to assure continuity in regulation for the safe delivery of gas services to New Hampshire customers.

The first and second unnumbered items, and <u>Items 1 through 5</u>, shall be completed with the same information as appeared in the "Rulemaking Notice Form" (Appendix II-C) as published for the Initial Proposal in the <u>Rulemaking Register</u>. <u>Item 6</u> shall identify the name, title, address, and telephone number of the person in the agency who can answer questions about the proposed rule and supply copies.

The agency shall then indicate, by checking the appropriate box on <u>Item 7</u>, whether it is requesting that it receive and respond to comments of the Committee legal counsel prior to the Committee meeting that is at least 28 days, but not more than 60 days, after the proposal is filed. In effect, this would be a request for postponement of Committee action. See RSA 541-A:12, I-a and Section 2.14 of Chapter 3 in the <u>Drafting and Procedure Manual for Administrative Rules (Manual)</u>.

In <u>Item 8</u> the agency shall list the full date, by month, day, and year, on which the "Rulemaking Notice Form" was published in the <u>Rulemaking Register</u>.
