On August 10, 2012, New Hampshire Optical Systems, Inc. (NHOS) filed a petition, pursuant to RSA 371:17, seeking approval for licenses to construct and maintain fiber optic cables over one public waterway and three railroads in Segment 16, a section of its cable line that begins in Northumberland and ends in Lancaster. NHOS filed revisions to its diagrams on January 7, 2013, on February 21, 2013, on July 11, 2013, and on January 21, 2014. On June 11, 2014, NHOS submitted a request to withdraw the August 10, 2012 petition and notified the Commission of the Segment 16 crossings pursuant to RSA 371:17-b, which became effective on June 19, 2013.

The June 11, 2014 filing included a list identifying the geographic and pole locations of each of the four crossings, in compliance with RSA 371:17-b. The four existing crossings included in the list filed on June 11, 2014, have been granted a permanent license, as the accompanying certificate attests. NHOS's license number for these crossings is CR-06-001-14.
