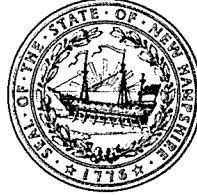

Response to Inquiry

Dear Mr. Dziemian:

The Executive Director has asked me to respond to certain inquiries you have filed in this docket. This responds to your letter dated February 4, 2015 and received by the Commission on February 6, 2015, and memorializes the key points of our discussion on February 9, 2015. This letter also confirms the direction provided to you previously by Commission Staff in response to your letter dated June 30, 2014 and received by the Commission on July 11, 2014.

Staff informed you that a registration for electric load or natural gas aggregation is not an asset that can be transferred by one company to another or through the merger of one company into another. Therefore, the electric load and natural gas aggregation registrations of White Column Office Solutions of New England LLC (White Column) were not transferred as the result of the merger last year between White Column and Neighborhood Energy of New England LLC (Neighborhood), in which transaction Neighborhood was the surviving entity (the Merger).

The Merger did not extend the termination date of Neighborhood's electric load aggregation registration date, October 2, 2015, to the date that White Column's electric load aggregation registration would have terminated, February 5, 2017.

The Merger also did not result in the transfer of White Column's natural gas registration to Neighborhood. Therefore, Neighborhood is currently not registered with the Commission as a natural gas aggregator. Pursuant to Puc 3003.04(a), in order for

Neighborhood to solicit or enroll customers for natural gas aggregation service in New Hampshire, Neighborhood must first complete all aspects of the registration process under Puc 3003.

If you wish to have the Commission issue a formal determination regarding these issues, you may file a petition for declaratory ruling pursuant to N.H. Code Admin. Rules Puc 207.01.
