Dear Mr. Simon:

On March 18, 2013 the Commission certified Loring Solar One, LLC (Loring Solar One) as eligible to acquire New Hampshire Class II renewable energy certificates (RECs) based on electricity produced at Loring Solar One's generation facility located at 598 Augusta Road, Washington, ME (Facility). The Facility is a customer-sited source as defined in the Commission's regulations at N.H. Admin. Rules Puc 2502.13. The New Hampshire Renewable Portfolio Standard certification code for the Facility is NH-II-13-028; the NEPOOL Generation Information System code for the Facility is NON36 123.

Pursuant to N.H. Admin. Rules Puc 2505.01(f), "[n]o customer-sited source shall be certified as eligible to acquire certificates under this part unless the source is located in New Hampshire." This rule implements the statutory restriction set forth in RSA 362-F:6, II. Based on these legal requirements, the Commission has determined that the certification of all customer-sited sources located outside of New Hampshire must be revoked, effective as of December 31, 2013.

Accordingly, the Commission has decided that the certification of the Facility granted in this docket shall be revoked, effective as of December 31, 2013, and the Facility shall not be eligible to obtain New Hampshire RECs with respect to electricity produced after December 31, 2013.

Please note that, pursuant to Puc 2505.13, any applicant, source, or other party aggrieved by a decision under Puc Part 2505 may file a petition for the Commission to conduct an adjudicative proceeding pursuant to RSA 541-A and Puc 200. The

Commission has directed that any such petition for an adjudicative proceeding regarding this revocation action should be filed within thirty (30) days of the date of this letter.
