Registration as a Natural Gas Aggregator

Dear Mr. Auger:

On April 12, 2013, U.S. Energy Services, Inc. (U.S. Energy) filed with the Commission an application for registration as a natural gas aggregator, together with the application fee of \$250.00.

Following its review of the filing, Commission Staff determined that the application for registration as a natural gas aggregator meets the requirements for registration pursuant to N.H. Code Admin. Rules Puc 3003.04. On April 24, 2013, Staff filed its recommendation to approve the application. The Commission will approve the registration with an effective date of May 16, 2013. The registration will expire at the end of business on May 15, 2015.

Additionally, please bear in mind that, pursuant to N.H. Code Admin. Rules Puc 3003.05 (a), each aggregator shall re-register with the Commission by filing an application for renewal at least 60 days prior to the expiration of its registration, i.e., in the case U.S. Energy, on or before March 15, 2015. Registration instructions and a checklist of requirements to properly file a renewal registration application are located on the Commission website at http://www.puc.nh.gov/Gas-Steam/CNGS-Aggregator%20registration%20application%20instructions%20and%20checklist.pdf.

All registered Natural Gas Aggregators in the State of New Hampshire are subject to specific requirements spelled out in N.H. Code Admin. Rules Puc 3000 - Competitive Natural Gas Supplier and Aggregator Rules. These rules can be found on our website at (http://www.puc.nh.gov/Regulatory/Rules/PUC3000.pdf).
