Staff and the parties agree to exchange discovery and filings by email. Staff and the parties assume that Staff's audit will be complete and available for use in developing Set 3 data requests. If there is a delay and the audit is not available for Set 3, Staff and the parties will likely request a delay in the procedural schedule. We will wait, however, if and until that happens before requesting a modification to the proposed schedule. Filings made directly to the Commission will follow the usual seven hardcopies plus an electronic copy, pursuant to Puc 203.02. Technical sessions contained in the proposed procedural schedule will be conducted so as to allow teleconferencing if parties are unable to physically attend.

With respect to PEU's request in its petition to waive portions of Puc Chapter 1604, the Commission reaffirmed its order and granted the waiver motion at the prehearing. Staff notes that action here to simply provide documentation of that action. Additionally, at the prehearing conference the Commission granted the Town of Litchfield's petition to intervene.
