Dear Mr. Hirsh:

On May 08, 2013, Solar Farm Bank submitted an application on behalf of Joel Fisher (Fisher) requesting Commission approval for Class II New Hampshire REC eligibility for his residential photovoltaic (PV) array pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law. On May 14, 2013, Solar Farm Bank submitted three additional applications for REC eligibility on behalf of Melinda Realty Associates (Melinda Realty), Joseph Shanks (Shanks), and George Havell (Havell). Certification of these facilities will enable Solar Farm Bank to add these facilities to its aggregation pursuant to Puc 2506.01 and recognized by the Generation Information System (GIS) under NON 35889.

Staff has reviewed the Fisher, Melinda Realty, Shanks, and Havell applications and has recommended approval of the above-named applicants' photovoltaic arrays as eligible to be aggregated by the Solar Farm Bank for Class II RECs effective May 08, 2013 for Fisher and May 14, 2013 for Melinda Realty, Shanks, and Havell, the dates Staff was able to determine that the applications were complete.

Since these facilities are customer-sited sources, their output is not recorded in the New England Power Pool Market Settlement System and, as a result must be monitored and verified by an independent monitor. The applications state that Paul Button, Energy Audits Unlimited, will monitor the facilities' output pursuant to N.H. Code of Administrative Rules Puc 2505.08 and 2505.09. Mr. Button will report these facilities' total output annually to the customer, the Commission and the NEPOOL Generation

Information System as part of the Solar Farm Bank's Class II aggregation pursuant to Puc 2505.09(h)(3).

The details for these facilities are listed in the following table.

Please be advised that, pursuant to RSA 362-F, the New Hampshire Public Utilities Commission has certified Solar Farm Bank's aggregation of the Joel Fisher (Fisher), Melinda Realty Associates (Melinda Realty), Joseph Shanks (Shanks), and George Havell (Havell) photovoltaic facilities.

Accordingly, Solar Farm Bank is eligible to be issued New Hampshire Class II Renewable Energy Certificates (RECs), effective May 08, 2013, for the Fisher facility and May 14, 2013 for the Melinda Realty, Shanks, and Havell facilities.
