These facilities' total output will also be included in the NHEC Class II Aggregation's total output reported to the NEPOOL Generation Information System as approved by the Commission on April 9, 2010.

The Commission has determined that NHEC has provided all the information necessary to demonstrate these facilities' eligibility for certification and hereby certifies the above named photovoltaic arrays as eligible for Class II RECs effective as of the dates listed in the table above.
