Dear Mr. Wiers:

On February 6, 2014, Satori Enterprises, LLC (Satori) submitted an application with the Commission to renew its registration as a provider of electric aggregation service. The application is incomplete and does not comply with the requirements of N.H. Code Admin. Rule Puc 2003. Commission Staff reviewed the filing and identified the following items which are missing from the application.

- 1) Certificate from the Secretary of State showing that the applicant is authorized to do business in New Hampshire.

Puc 2006.02 Form for Initial and Renewal of Aggregators.

(5) A copy of the applicant's authorization to do business in New Hampshire from the secretary of state, if anything other than an individual

- 2) Application renewal fee of \$125.00.

Puc 2003.05 Renewal of Notice by Aggregators

(c) Except as provided in Puc 2003.04(e), an aggregator shall include with its application for renewal a renewal fee of \$125.00.


Commission Staff noted that your application was entered on a form that is no longer used and that the requests on the form are not the same as those in the current rules, at Puc 2006.02. The rules are available at, <http://puc.nh.gov/Regulatory/rules.htm>. Select the link for Puc 2000. In order to complete a renewal application, copy the Puc 2006.02 section of the rules from the PDF to a Word document and address each item one-by-one.

In order to complete your application you should respond accordingly to the items listed above. When responding, please address your letter to Debra A. Howland, Executive Director, and reference the docket number listed on the subject line of this letter.

Pursuant to Puc 2003.04 (h), please provide all information requested within 60 days of the date of this letter, on or before **April 12, 2014**. Puc 2003.04 (h) is copied below.

Puc 2003.04(h) If the commission has requested information or clarification to complete an application for registration, and such information or clarification is not provided within 60 days of the request, the commission shall suspend the application. If, after 120 days of the date of the request, the applicant has not provided the requested information or clarification, the commission shall reject the application. If an application is rejected, the application fee shall be forfeited and the applicant shall be required to submit a new application and fee prior to acting as a CEPS in New Hampshire.
