Request to Modify Statewide Low-Income Electric Assistance Program, Order No.

25,643 (Mar. 28, 2014)

Dear Mr. Epler:

On April 15, 2014, Unitil Energy Systems, Inc. (UES), requested a four day delay in the effective date of *Statewide Low-Income Electric Assistance Program*, Order No. 25,643 (Mar. 28, 2014), as applied to UES.

Order No. 25,643 approved three changes to the Electric Assistance Program (EAP) that were recommended by the EAP Advisory Board to address a surplus in the EAP fund. These changes raised the maximum income eligibility, increased three of the program's discount tiers, and restarted the two year period for temporary increases previously approved. The changes were to go into effect 30 days from the order's effective date, or April 27, 2014.

UES requested a delay in the effective date to May 1, 2014, because UES anticipates approval of a step increase in its rates to also go into effect May 1. The step increase was provided for in the settlement agreement reached in UES's last rate case, Docket No. 10-055, and is now before the Commission for approval in Docket No. DE 14-063. A hearing was held in that matter on April 18. If approved, the step increase will be effective May 1, 2014.

UES argued that making the two rate changes occur on the same day will advance administrative efficiency, avoid confusion for EAP customers who would otherwise have two rate changes within days, and will be consistent with Order No. 25,643.

Staff, the Office of Consumer Advocate, The Way Home, and the Community Action Programs advised the Commission that they did not object to UES's request.

Although filed as a waiver request, UES seeks a ministerial change in an order, not the waiver of a rule. The Commission applies "a public interest standard in our review of a requested modification of an order." Florida Power & Light Co., Order No. 25,138 at 5 (Aug. 12, 2010). In considering such changes to an order, the Commission considers whether the modification is agreed upon, is clerical or ministerial in nature, involves timing or scheduling, or pertains to other non-substantive terms. These factors militate in favor of granting UES's request. Notice and a hearing are not required because the underlying order "was made under a provision of law that did not require a hearing and a hearing was, in fact, not held." RSA 365:28.

The Commission has determined that the standards for a modification to Order No. 25,643 are satisfied here and that granting the request is consistent with the public good. Accordingly, the effective date of Order No. 25,643 as to UES has been extended to May 1, 2014.
