To the Parties:

Pursuant to the procedural schedule established in this docket, a Staff Recommendation and OCA/Intervenor testimony is due May 30, 2014. In light of discovery responses from Liberty, on May 29, 2014, Staff filed a request to extend the deadline to June 4, 2014. Staff represents in its request that the OCA concurs with the request but, with the short notice, Staff was unable to contact Liberty regarding its position on the request.

The Commission has determined that the extension will not unduly delay the proceeding or adversely affect the rights of any party. Accordingly, the request has been granted. The Commission will also extend the deadline for Liberty to file its response to the Staff report from June 5, 2014 to June 6, 2014.
