

Dear Ms. Howland:

Enclosed for submission to the New Hampshire Public Utilities Commission ("Commission") are an original and two copies of Granite Telecommunications, LLC ("Granite") New Hampshire P.U.C. Tariff No. 1. This Tariff sets forth the rates, terms, and conditions associated with Granite's provision of switched exchange access services in the State of New Hampshire.

The Company's Tariff complies with the Federal Communications Commission's ("FCC") Report and Order and Further Notice of Proposed Rulemaking, in Docket Nos. WC Docket No. 10-90, et al., FCC 11-161, Second Order on Reconsideration in Docket Nos. WC Docket No. 10-90, et al., FCC 12-47, and Sections 51.911 and 61.26(c) of the FCC's rules, 47 C.F.R. §§51.911, 61.26(c), effective July 1, 2014.

³ Pursuant to Section 61.26(c), "The benchmark rate for a CLEC's switched exchange access services will be the rate charged for similar services by the competing ILEC. If an ILEC to which a CLEC benchmarks its rates, pursuant to this section, lowers the rate to which a CLEC benchmarks, the CLEC must revise its rates to the lower level within 15 days of the effective date of the lowered ILEC rate." [Emphasis supplied]. On June 16, 2014, the Verizon Telephone Companies ("Verizon") amended Section 6 of Verizon's Tariff F.C.C. No. 1. The Company's composite originating and terminating switched access rates reflect the corresponding Verizon rates, effective July 1, 2014.
