Procedural Order Re: Transferring to New Docket

On April 1, 2024, Mill Brook Village Water System, LLC (Mill Brook) submitted an identical filing in these two dockets containing a revised tariff page with an effective date of January 1, 2024. The associated cover letter represented that Mill Brook lowered its water rates consistent with Order No. 25,754 (January 15, 2015) in Docket No. DW 14-176, which requires Mill Brook to adjust its rates when it increases the number of customers its water system serves. Last year, the Commission opened Docket No. DW 23-042 to resolve a similar filing from Mill Brook, wherein Mill Brook filed a proposed tariff page with an effective date of July 1, 2022 to reflect a previous increase in its customer count. That docket was closed on July 18, 2023 after the Commission accepted the tariff filing by order *nisi*.

For the purposes of administrative clarity, the Commission will open a new docket to resolve the proposed revision to Mill Brook's water system effective January 1, 2024. The Clerk's Office is directed to transfer the April 1, 2024 tariff filing to a new docket: Rate

Adjustment Filing, Docket No. DW 24-062. Docket Nos. DW 14-176 and DW 23-042 are to remain closed.
