OFFICE OF ENERGY AND PLANNING RESPONSE
TO PSNH MOTION TO STAY PROCEEDINGS

NOW COMES the State of New Hampshire Office of Energy and Planning ("OEP"), by and through counsel, the Office of the Attorney General, and submits this response to the Motion to Stay Proceedings filed by Public Service Company of New Hampshire ("PSNH"). OEP states as follows:

1. Pursuant to its motion, PSNH seeks a stay of proceedings in both Docket DE 11-250, Investigation of Merrimack Station Scrubber Project and Cost Recovery (the "Scrubber Docket") and DE 14-238, Determination Regarding PSNH's Generation Assets (the "Divestiture Docket") to allow the parties to engage in a collaborative discussion aimed at resolution of both Dockets. Further, PSNH indicates Senator Jeb Bradley's express support for such a collaborative negotiation, which may include legislative action.

2. OEP interprets PSNH's request as an indication that PSNH is prepared to propose settlement terms that would provide significant economic and other benefits to the State, ratepayers and other interests.

3. OEP is an intervenor in the Divestiture Docket, but was not a party to the Scrubber Docket. OEP's interests in the Divestiture Docket include ensuring that residential and

business customers have access to affordable, reliable electricity that allows for innovation and economic growth, protecting the state's natural resources, and fairly apportioning among ratepayers and utility shareholders the costs and risks of operating and/or divesting PSNH's generation assets.

4. OEP is open to good faith settlement negotiations that include all parties who are willing to participate and that offer the potential for a quicker and more efficient resolution of complex issues in each docket. To be successful, such negotiations will require substantive compromise and a willingness by PSNH to offer settlement terms that provide concrete, meaningful benefits to ratepayers, workers, the environment, and other interests.

5. Accordingly, OEP does not object to PSNH's request for a stay of proceedings in both dockets while the parties pursue a negotiated settlement that reduces electricity rates, decreases ratepayer responsibility for the post-restructuring costs of PSNH's generation assets, and provides other important benefits as referenced above.




