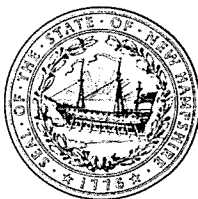

Re: DT 15-138: Intrastate Access Rate Tariff Filings by CLECs

Dear Carey:

On July 16, 2015, Neutral Tandem-New Hampshire, LLC (Neutral Tandem) submitted a filing described as a "CLEC Rate Schedule."

We appreciate your effort to provide transparency in access rates. However, New Hampshire laws regarding tariffs apply only to filings made by authorized public utilities. Neutral Tandem has voluntarily registered as a telecommunications carrier, but that status does not allow the Commission to accept tariffs and/or rate schedules from the company.

Authorizations to provide utility telephone service issued by the Commission in previous years have expired pursuant to Puc 404.01(f). Only those companies currently operating as telephone utilities, in particular by providing non-VoIP and non-IP-enabled voice service to end users, were issued new certifications as telephone utilities.

In light of this, Staff will not act upon this filing.
