Please accept an original and two copies of this letter for filing with the New Hampshire Public Utilities Commission (“Commission”) as a request by Northern New England Telephone Operations LLC (the “Company”) for approval to effectuate a name change in Northern New England Telephone Operations LLC’s fictitious business name from FairPoint Communications - NNE to Consolidated Communications - NNE.

By this letter, Northern New England Telephone Operations requests a letter of authorization from the Commission changing its certificated name from Northern New England Telephone Operations LLC d/b/a FairPoint Communications - NNE to Northern New England Telephone Operations LLC d/b/a Consolidated Communications - NNE, with an effective date of February 19, 2018. This new d/b/a is to be reflected in all company references, including all operating authorities granted to the Company by the Commission.

The Company is filing a revised tariff Title Sheet for Tariff No. 2, Tariff No. 3 and Tariff No. 4 to reflect the new name Northern New England Telephone Operations LLC d/b/a Consolidated Communications - NNE, and requesting an effective date of February 19, 2018 for this page, contemporaneously with this name change request. This tariff does not change the corporate entity actually providing service, any of the terms and conditions, or any of the service offerings of Northern New England Telephone Operations LLC.

Also enclosed is an updated contact and trade name information NHPUC Form T-1 for Northern New England Telephone Operations LLC d/b/a Consolidated Communications - NNE.
