

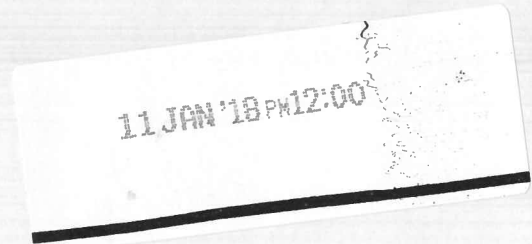

(the "Company") for approval to effectuate a name change in UI Long Distance, Inc. fictitious business name from FairPoint Long Distance to Consolidated Communications Long Distance/UI.

By this letter, UI Long Distance, Inc. requests a letter of authorization from the Commission changing its certificated name from UI Long Distance, Inc. d/b/a FairPoint Long Distance to UI Long Distance, Inc. d/b/a Consolidated Communications Long Distance/UI, with an effective date of February 19, 2018. This filing does not change the corporate entity actually providing service, any of the terms and conditions, or any of the service offerings of UI Long Distance, Inc.


Also enclosed is an updated contact and trade name information NHPUC Form T-1 for UI Long Distance d/b/a Consolidated Communications Long Distance/UI.
