Commission Notice of Tariff Suspension and Staff Investigation of Proposed Changes

To the Parties:

On March 9, 2018, Lakes Region Water Company, Inc. (Lakes Region) filed a final version of a proposed NHPUC No. 7 – Water version of its tariff, seeking permission to supersede its current NHPUC No. 6 – Water tariff. Subsequently, on March 16, 2018, Staff filed a letter with the Commission, recommending that the Commission approve the revised tariff for Lakes Region.

The Commission has reviewed Staff's recommendation, and the subject NHPUC No. 7 – Water proposed tariff for Lakes Region, and has determined that suspension of the proposed tariff pursuant to RSA 378:6, I(b), for an initial period of 3 months, or until June 27, 2018, is warranted, to facilitate additional investigation of the proposed tariff's provisions by Staff. This secretarial letter will serve as the Commission's initial suspension Order for this proceeding.
