

On September 20, 2017, Hampstead Area Water Company, Inc. (HAWC) filed with the New Hampshire Public Utilities Commission (Commission) a petition to: (i) expand its franchise within the Town of Strafford and operate a water system within that franchise area; (ii) acquire the assets of Bow Lake Estates Water Works, Inc. (Bow Lake), and (iii) charge its current consolidated water rates in the new franchise area once water meters are installed. HAWC is a New Hampshire corporation and regulated water utility that provides service to approximately 3,600 customers in the Towns of Atkinson, Chester, Danville, East Kingston, Fremont, Hampstead, Kingston, Newton, Nottingham, Plaistow, Salem and Sandown. Bow Lake is a regulated public water utility serving approximately 40 customers in a limited area of the Town of Strafford.




