Congratulations on your loan from the Drinking Water and Groundwater Trust Fund (Trust Fund). The Trust Fund Advisory Commission authorized borrowing funds up to \$3,375,000 for the Pennichuck Core water main replacement project. The next step is to enter into a loan agreement and obtain Governor and Council approval. In order to enter into a loan agreement Pennichuck Water needs to submit a final application. The documents needed for the final application are listed on the enclosed checklist.

A final application needs to be submitted by June 30, 2018. We encourage you to move forward at this time to seek the authority to borrow. The terms of the loan are as follows:

- Any project related, non-construction work completed after the date of the Advisory Commission approval (11/2/17) is eligible for reimbursement.

We ask that you keep us informed of progress made toward seeking the authority to borrow. Should your project not move forward, please contact us as soon as possible. Once the required paperwork is returned, NHDES will prepare loan agreement documents. We look forward to working with you on your infrastructure project.
