On February 14, 2019, Taurus Advisory Group LLC (Taurus) submitted an application with the Commission to register as a provider of electric aggregation service. On February 20, 2019, Taurus filed a revised version of its application which designated certain information it considers to be confidential.

Commission Staff filed a memorandum on February 22, 2019, in which it confirmed its review of the application and its conclusion that the application meets the requirements for registration under N.H. Code Admin. Rules Puc 2000. Staff recommended that Taurus's registration application be approved for a two-year term and that the information designated as confidential by Taurus be afforded confidential treatment.

Your application for registration is approved effective as of February 25, 2019, under Puc 2003.05(g)(1). The registration is for a term of two years and expires at the close of business on February 25, 2021. Pursuant to Puc 2003.06(a), you must submit your renewal application at least 60 days prior to the expiration of the approved registration term, on or before December 23, 2020. In addition, the information in Taurus's application that you designated as confidential will be afforded confidential treatment.
