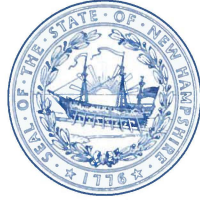

Proposed Procedural Schedule for Temporary Rate Filing

Dear Ms. Howland:

On May 21, 2019, a prehearing conference was held in the above-captioned docket. At the prehearing conference, the Commission granted the petitions to intervene filed by Clean Energy New Hampshire and The Way Home.

Following the prehearing conference, the parties met in technical session and agreed to the following procedural schedule for the temporary rate case.

Rolling Data Requests	Through May 29, 2019
Responses Due	5 Business Days
Technical Session/Settlement	
Conference	June 5, 2019 at 10:00 (all day)
Merits Hearing	June 18, 2019

Public Service Co. of N.H. d/b/a Eversource Energy agreed to provide data request responses within 5 business days of the receipt, or as soon as possible following the five day period.

Staff and the parties, including the Office of Consumer Advocate (OCA) also agreed that The Way Home and Clean Energy New Hampshire are interveners in the permanent rate case, the second phase of this proceeding.

The parties further agreed that the Commission should issue a supplemental order of notice once the permanent rate request is filed. A supplemental order of notice should schedule a prehearing conference and a technical session for the permanent rate case. The issuance of a supplemental order of notice would also allow additional interested parties to intervene in the permanent rate case phase of this proceeding.
