Application to Renew Registration as a Provider of Electric Aggregation Service

Dear Mr. Praeger:

On February 10, 2020, AvidXchange, Inc. (AvidXchange) submitted an application with the Commission to renew its registration as a provider of electric aggregation service. Staff reviewed the application and determined that it is complete.

Commission Staff filed a memorandum on February 18, 2020 summarizing its review and conclusions and recommending that a waiver be granted of the renewal filing deadline under N.H. Admin. R., Puc 2003.06(a) and that AvidXchange's registration renewal application be approved for a two-year term, beginning on January 29, 2020, pursuant to Puc 2003.06(e)(1).

The Commission has granted the recommended rule waiver, having found that it would serve the public interest and would not disrupt the orderly and efficient resolution of matters before the Commission, under Puc 201.05. Accordingly, AvidXchange's application for registration renewal is approved, effective as of January 29, 2020, under Puc 2003.06(e)(1). The renewed registration is for a term of two years and expires at the close of business on January 29, 2022. Pursuant to Puc 2003.06(a), you must submit your next renewal application at least 60 days prior to the expiration of the approved registration term, on or before November 30, 2021.

Please be aware that registered providers of electric aggregation service are subject to specific requirements contained in N.H. Admin. R., Puc 2000 – Competitive Electric Power Supplier and Aggregator Rules. These rules are available at:
