Dear Ms. Bartlett:

On July 27, 2020, Best Practice Energy, LLC (Best Practice) submitted an application to the Commission to renew its registration as a provider of natural gas aggregation services.

Commission Staff (Staff) filed a memorandum on July 31, 2020, in which it confirmed its review of the application and its conclusion that the application meets the requirements for registration under N.H. Admin. R., Puc 3000. Staff recommended that Best Practice's registration renewal application be approved for a two-year term, beginning on August 13, 2020.

The Commission has approved Staff's recommendation. Accordingly, Best Practice's application for registration renewal is approved, effective as of August 13, 2020. The renewed registration is for a term of two years and expires at the close of business on August 13, 2022. Pursuant to Puc 3003.06(a), Best Practice must submit the next renewal application at least 60 days prior to the expiration of the approved registration term, on or before June 14, 2022.

Please be aware that registered providers of natural gas aggregation services are subject to specific requirements contained in N.H. Admin. R., Puc 3000 – Competitive Natural Gas Supplier and Aggregator Rules. These rules are available at: <http://www.puc.nh.gov/Regulatory/Rules/PUC3000.pdf>.
