Dear Mr. Wirth:

On September 8, 2020, Pursuit Energy Solutions, LLC (Pursuit) submitted an application to the Commission to renew its registration as a provider of natural gas aggregation services. Pursuant to Puc 3003.05(a), the application was filed too early. On October 6, 2020, Pursuit re-filed their application to renew its registration as a provider of natural gas aggregation service.

Commission Staff (Staff) filed a memorandum on October 9, 2020, 2020, in which it confirmed its review of the application and its conclusion that the application meets the requirements for registration under N.H. Admin. R., Puc 3000. Staff recommended that Pursuit's registration renewal application be approved for a two-year term, beginning on January 23, 2021.

The Commission has approved Staff's recommendation. Accordingly, Pursuit's application for registration renewal is approved, effective as of January 23, 2021. The renewed registration is for a term of two years and expires at the close of business on January 23, 2023. Pursuant to Puc 3003.06(a), Pursuit must submit the next renewal application at least 60 days prior to the expiration of the approved registration term, on or before November 24, 2022.

Please be aware that registered providers of natural gas aggregation services are subject to specific requirements contained in N.H. Admin. R., Puc 3000 – Competitive Natural Gas Supplier and Aggregator Rules. These rules are available at:
