Dear Ms. Strausser:

On March 1, 2021, Evolution Energy Partners, LLC (Evolution) submitted an application to the Commission to register as a provider of natural gas aggregation services. On March 17, 2021, Evolution filed an amended application.

Commission Staff (Staff) filed a memorandum on April 26, 2021, in which it confirmed its review of the application and its conclusion that the application meets the requirements for registration under N.H. Admin. R., Puc 3000. Staff recommended that Evolution's registration application be approved for a two-year term.

The Commission has approved Staff's recommendation. Accordingly, Evolution's application for registration is approved, effective as of April 26, 2021. The registration is for a term of two years and expires at the close of business on April 26, 2023. Pursuant to Puc 3003.06(a), Evolution must submit a renewal application at least 60 days prior to the expiration of the approved registration term, on or before February 25, 2023.

Please be aware that registered providers of natural gas aggregation services are subject to specific requirements contained in N.H. Admin. R., Puc 3000 – Competitive Natural Gas Supplier and Aggregator Rules. These rules are available at:
